Happy New Year! We are now at the halfway point in the Rotary Year. I hope everyone had a safe and happy holiday season and had a chance to spend quality time with friends and family. I know some of you saw the holiday video message on our district web site. I think the holiday season is a great time to recharge and reflect on what you plan to accomplish in the upcoming year. Along those lines, I hope you all are as excited about the second half of the year as you are the first and that we all plan to complete 25-26 strong.

As a district, we are well along the path to achieving some of our 25-26 goals. We are currently at 3818 members in our 67 Rotary clubs, have achieved \$287,325 of annual fund giving, \$175,047 towards Polio eradication and with endowment and other giving, we have achieved over \$706K in charitable giving! I could not be more proud of you all! We still have 6 months left to give, do many more service projects and take action on the club's strategic plan. Please use your time wisely. I enjoyed doing several impactful service projects for children in December. I want to tell you two very quick stories. I had 2 incredible "Rotary moments" a few weeks ago as I was doing holiday season service projects with two Rotary clubs.

The first moment came when I was able to go to the **South Cobb Rotary Club**'s annual holiday luncheon. The club, led by President Pam Kramer, invites in 20 local school children from low income families from a local school. Santa Claus was present so the event was full of holiday cheer, and it was lots of fun to see

the children are so excited and happy. The club fed the students, then gave very generous presents and watched the children open up the presents. I sat with an eight-year old and his six-year old sister. The siblings provided me a "Rotary moment" when they said they didn't think they would get presents this year because their mom just spent their remaining \$200 on a table the family needed. I saw how excited the children were when they realized they got all kinds of great gifts due to the club's generosity!! What an impact the South Cobb club makes every year in the lives of these children. (Well done and thank you for having me be part of it).

I was also a Santa's helper with the **Rotary Club of Atlanta Southern Crescent** that does an annual event allowing children to shop with simulated money for the members in their family. It was so heartwarming to see the smiling faces and excitement of 65 low income children who are able to shop, learn some economic basics, have their gifts wrapped by smiling Rotarians and nursing home staff and then enjoy some pizza. The Atlanta Southern Crescent club provided me with a second Rotary moment as I saw the absolute joy on "Junior's" face as the club president, Mahli Lowder, his big sister, he and I "shopped" for gifts for his family. Thank you so much as well for doing such a great event that truly changes lives.

I spent some time in the last few days doing a personal service project and delivered food to our local fire and police departments and then Anna and I took treats to Piedmont Atlanta Hospital to our (nurse) daughter Claire who was working on Christmas Day.





# **Foundations Working Together**



Hard to believe we have reached a new year, but here we are! Welcome 2026 and let's look forward to another great year in Rotary and our work with the Foundation.

There was some great news that came out of the Bill & Melinda Gates Foundation earlier in December that you may have missed in the midst of all the hustle and bustle of the Thanksgiving to the Christmas and Hanukkah holidays. The Gates Foundation has pledged \$1.2 billion dollars for 2026-2029 to the Global Polio Eradication Initiative (GPEI) dedicated to vaccinating 370 million children annually as well as focusing on disease tracking and surveillance and working to beef up the healthcare systems in the endemic countries of Afghanistan and Pakistan. The announcement of this initiative came on December 8 during a summit being held in Abu Dhabi.

The \$1.2 billion was part of a \$1.9 billion collective pledge that included \$450 million from Rotary International and an additional \$100 million from Bloomberg Philanthropies. It is amazing what can be raised when great organizations collaborate. Though Polio cases have dropped by 99% since 1988, still there have been outbreaks over that time in 20 different countries around the globe which requires making mandatory a sustained on-going investment if we are to achieve full eradication of the disease. Once we do achieve full eradication, and we will, it will be the second human disease to achieve that status, second only to smallpox. We'll get there with your dedicated support within Rotary. We are very blessed and thankful to the Gates Foundation for their continued support to stop the spread of Polio and support of the Rotary Foundation.

Let me shift gears to another topic for the rest of my article this month. There is an outstanding article written by Carl W. Davis, who is a Senior Major Gifts Officer with The Rotary Foundation. We've made that easy for you to view the entire article, thanks to the efforts of PDG Alex Smythe who placed the article on our district website. Carl discusses the "Big Beautiful Bill Act" that has been all the rage in Washington since its passage this past summer. Much of the article focuses on planning which he was encouraging us to consider as 2025 was coming to a close. He points out the large impact the Bill will have on Charitable Giving. His concern is with the fact that the amount of the new standard deduction will now be permanent and will make it more difficult to file an itemized return for most people. In response he recommended using Rotary's Donor Advised Fund (DAF) that allows the Donor to receive a tax receipt for a charitable gift in one year where the charity will receive the give in a different tax year.

Carl points out that starting in 2026 everyone is eligible to give dollars to charity to minimize their tax bill even if they don't itemize. He states that single-filers can do so for up to \$1,000 and joint-filers up to \$2,000 per year. This is a good way to keep marching up the Paul Harris giving ladder and can easily place the donor in the Paul Harris Society. No better time to look at doing so than now.

There are many other points Carl makes and I highly encourage you to read the entire article and study it for yourself and, as he suggests, doing so by consulting your own personal tax advisor is always the best approach. Don't take my word for it as I'm certainly not a Tax adviser and don't pretend to be. Still, there are good potential approaches for us all to consider as we support our Foundation. Let's end the year with a big Rotary big! Look at the good we do in the world. 

## Stone Mountain People of Action at Work in South Africa!



A new member of the **Rotary Club of Stone Mountai**n, Jeremy Anderson and his wife, Traci, have been living Rotary's motto of "Service Above Self" and making an impact for many years. In 2018, Jeremy and Traci launched their nonprofit, Next Level Living, Inc. Since then, they've fed an average of 1,000 starving children every week in Cape Town, South Africa —nourishing not only their bellies but their hearts and minds.

Believing deeply in the power of education, the Andersons have also sponsored 60 students to attend the College of Cape Town since 2020. They live by the conviction that they are "blessed to be a blessing," and their generosity continues to open doors and change lives around the world.

On Thanksgiving night 2025, ten individuals, including DGE Cynthia Dorsey Edwards and her husband, Lonnie; PE Maxine Cain and her daughter, Lauren; Eric Baker (an executive with Audacy, a multi-platform audio & entertainment company), left Atlanta to join Jeremy, Traci, and their family in Cape Town. They went to provide support to and participate with the Andersons in their service to the community. They were also filled with anticipation of experiencing the continent of Africa for the first time.

During the nine days that the Atlanta group was in Cape Town, Next Level Living delivered two back-to-back fundays that reached more than 3800 children across Sonderend Primary and Kampies informal settlement – flooding both communities with joy, dignity, and connection through massive water slides, arts and crafts, sports zones, face painting, music, hot meals, fresh fruit, desserts, party packs, and full volunteer support. For many learners and families, these moments were once-in-a-lifetime experiences that restored hope in places where it's often fragile.

Across both sites, more than 40 volunteers helped serve 500 liters of akhni, distribute tons of fruit, hand out thousands of cold treats, and create a safe, electrifying atmosphere that uplifted over 300 families in just 48 hours. These two events proved what becomes possible when NGOs, brands, sponsors, and community leaders (including Rotarians) unite under one mission: to bring unforgettable life-shaping moments to children who need them most.

# Decatur Celebrates Bedros Sharian Jr. at 100 Years

On Friday, November 21, at the Historic Decatur Courthouse, the **Rotary Club of Decatur** and the City of Decatur, Georgia honored long-time member **Bedros Sharian Jr.** as he approached his  $100^{th}$  birthday on Thanksgiving Day. City Manager and Rotary member, Andrea Arnold, read the proclamation signed by Mayor Patricia M. Garrett that proclaimed November 25, 2025, as Bedros Sharian Jr. Day. Former Decatur Mayor Walt Drake also provided a historical perspective on Bedros' rich life and his impact on the Decatur Community.

#### **PROCLAMATION**

**WHEREAS**, Bedros Sharian, Jr. was born on November 25, 1925 to Armenian immigrants who arrived in the United States in the early 1900s, whose journey to this country has been an integral part of his rich family legacy; and

**WHEREAS**, in 1931, Bedros' parents established the Sharian business, initially starting with a rug cleaning operation in their backyard on Drexel Avenue, which eventually grew to become a cornerstone of the Decatur business community; and

**WHEREAS**, Bedros graduated from Decatur Boys High School, attended Emory University at Oxford, and served in the U.S. Navy during World War II, epitomizing the courage and sacrifice of the "Greatest Generation"; and

**WHEREAS**, upon returning to Decatur in 1946, Bedros completed his education at Emory University, joined the family business, and became its President, and later Chair of the Board of Directors, always leading with integrity, dedication, and an unwavering commitment to excellence; and

**WHEREAS**, Bedros has been instrumental in guiding Sharian, Inc. through four generations of ownership and management, fostering not only its success but also a strong legacy of service to the community, and

**WHEREAS**, Bedros' contributions to the Decatur community extend beyond business, as he served as President of the Decatur Rotary Club and the Executive Club of Decatur, with nearly 50 years of active service to both organizations; and

**WHEREAS**, it is fitting that we celebrate Bedros Sharian, Jr. on the occasion of his 100th birthday, recognizing his remarkable legacy as a Decatur business leader, a proud American, a distinguished World War II veteran, and the patriarch of the Sharian family, whose contributions to our city have been immeasurable.

**NOW, THEREFORE,** I, Patricia M. Garrett, Mayor of the City of Decatur, the "City of Homes, Schools, and Places of Worship," do hereby proclaim November 25, 2025 as **BEDROS SHARIAN, JR. DAY** in honor of his 100<sup>th</sup> birthday and in recognition of his lifelong dedication to Decatur, his service to our nation, and his exemplary leadership in business and community life.





It spoke of Mr. Collier's "...magnanimous strengths, with an unimpeachable reputation for integrity, intelligence, fairness and kindness, and by the example he made of his life, he made this world a better place in which to live."

The resolution called Mr. Collier "a compassionate and generous man" .... who "will long be remembered for his love of family, friendship and community and will be missed by all who had the great fortune of knowing him."

Mr. Greene represents House District 154, which includes Early County.

**Hometown Hero Recognition Sparks Grassroots Roswell Rotary Challenge...** 



The **Roswell Rotary** Hometown Hero for November story has a sequel! Brother's Keeper Foundation founder, Chris Cathers, with his body fighting Stage 4 Cancer and PTSI, but his spirit needed to create a foundation where Veterans could find help without barriers and only resolutions. During the inspirational November presentation to Chris, Roswell Rotarian John Michael Brunetti was so moved to throw out a match of \$10,000 so Chris could see veterans getting what they needed fast. "Match it," he said. "Let's do something worthy of these veterans." The spark was ignited. If that wasn't enough, after the meeting, Chris shared with Roswell Rotary Club President Trummie Lee Patrick III that another donor in his organization had also stepped forward and would match what Roswell Rotary could raise. Anonymous. No fanfare. No spotlight. "I'll match whatever you raise," they said. In an instant, the challenge of one Rotarian could be seen to go from \$10,000 to \$20,000. Then \$20,000 would become \$40,000. At a December meeting, the challenge was made public to the 200 folks in the room and, within 8 minutes, almost \$40,000 was raised creating a new budget for Brother's Keeper just from Roswell Rotary! NOTE: This is not considering the additional match!

Chris Cathers had the courage to create something new where no path existed. He still calls, still listens, still shows up. Even now—especially now—he serves with a spirit that defines Service Above Self.

From Brothers Keeper: Your generosity allowed us to fully stabilize five veterans in acute need. And, now we invite you to match our commitment and help us complete the remaining three service projects for veterans needing life-changing companions, service dogs, for heroes who need them to navigate PTSD, mobility impairment, and daily living.

#### Your \$40,000 will:

- 1. Fully fund the highest-leverage, lowest-cost stabilization cases: These are five veterans where a relatively small amount of money prevents homelessness, relapse, and/or medical decline.
- 2. Prioritize life-or-death mobility, housing stability, and mental health continuity for three more veterans by partially but yet significantly provide a meaningful portion of funding for not only their survival but stabilization and so they can reclaim their life.
- 3. Ensure equity across needs while protecting against "catastrophic setbacks.

This \$40,000 has become far more powerful—certain to change lives towards stability and, hopefully, flourishing. Nothing is certain and these plans are based on known needs and hopeful outcomes. Don't miss the point.... there is something happening because a group of people dared to think outside the norm, outside the box and find different ways to help! "I couldn't be more proud of this kind of potential brewing in our club," RRC President Trummie Lee Patrick III.

And this is where success is found —in a place far deeper than a ballpark, a backyard, or even a Rotary Club meeting. It is found at the intersection of imagination and compassion, where ordinary people refuse to let the world remain as it is. The courage of Chris Cathers is turning his remaining days into a legacy of hope for those who once fought for us. And the challenge made by one Rotarian will hopefully create a wave of generosity that will change lives we have not yet met.
