Survey Results: Dunwoody Rotary Charitable Fund (DRCF)



On November 15, **President Rick Otness'** presentation on survey results focused on the Dunwoody Rotary Charitable Fund (DRCF). He started with a brief history of the Dunwoody Rotary charitable fund, saying it was started in the mid-1990s to support the club's charitable work both locally and around the world. Most of its funding comes from the Governor's Ball and RunDunwoody, along with some individual contributions.

Over the years, guidelines were set by past boards of directors for how much the club might draw from the fund for projects each year - based on the success of our fundraising and our investments, with the idea we would have money in the fund to continue our charitable work in a year where the economy and/or fundraising was challenging. We also established Trustees for the Charitable Fund. The current Trustees of the DRCF are **Jim Glass, Buzz Law, and Carter Stout**.

For the five calendar years (2012 thru 2016), the Dunwoody Rotary Charitable Fund has raised over \$390,000 - primarily from our two annual fundraising events: The Governors Ball and Run Dunwoody. During those same 5 years the DRCF also realized investment appreciation of approximately \$136,000. After funding projects, the DRCF had a value of \$366,484 as of October 3, 2017.

Rick noted that Dunwoody Rotary Charitable Fund is totally separate from the Rotary (International) Foundation, although some of our international projects are funded by a combination of Charitable Fund and Rotary Foundation dollars.

In the survey, we asked two questions about the Charitable Fund - how we should spend dollars and what was a reasonable safety net for the fund - that is, how much should we hold in reserve.

You may recall, 55% of those responding said we should target our charitable spending using a 50/50 split between local and international projects. The remaining 45% said we should invest 75% locally and 25% internationally.

When asked what kind of a safety net we should have, nearly 75% of those responding said we should keep between \$100,000 and \$250,000 in our Charitable Fund at any given time.

There were several written comments on this topic. Overall, a central theme of those comments focused on spending our dollars on projects with significant impact - saying we should neither spend the money just because we have it, or limit our investment in significant projects just to maintain a charitable fund balance.

It was also noted at the meeting, many people feel the club often spends small amounts and makes little impact on some of the charities we donate to. The thought being the Board and Grant committee leaders have a fear of spending, due to not having information on what the club wanted as a safety net. A lack of direction. Now we have it!

We plan to have more conversation with our members in January and February regarding the charitable fund and the projects of the future.

The program includes:

- A field tour to Bergen (administered by the University of Oslo),

- and visiting for one week with Norwegian Rotary host families.

The recipients of the scholarships must pay their travel expense to and from Atlanta, plus provide their own personal spending money.

GENERAL COURSES:

GRADUATE COURSES:

Educational System of Norway, Physical Education in Norway, Medical Care and Health Services in Norway, Peace Research, Energy Planning and the Environment, Special Education, Kulturlivet i samtidsn Norge, Norwegian Petroleum Law and Transboundary Pollution.

The University of Oslo will issue a Certificate of Achievement to all who satisfactorily complete the Summer School courses. Credits may also be certified.
