Planning for the RI Convention in Atlanta in June 2017



Joe DeSantis chairs the committee of the Rotary Club of Marietta planning our Club's role in attending and hosting upwards of 40,000 Rotarians and guests coming to Atlanta for the RI Convention, June 10-14. President Judge Reuben Green, President-Elect Caitlyn Cooper, Director of Club Administration Marla Blackstone, Norman Aiken, and Dale Covington serve on Joe's committee.

Last Friday Joe, President Reuben, Norman and Dale met with RI Director Robert Hall to share lunch at Shillings on the Square and discuss the Convention's organizational structure and what happens each day. Opening Ceremonies will be in Olympic Park, near ten hotels and the World Congress Center, site of principal meeting sessions and the House of Friendship. On Tuesday evening, June 13th, there will be a special reception for returning GRSPs at the Fox Theatre. A huge, 100th birthday celebration for the Rotary Foundation occurs on the Convention's last day. Already 21,000 people have registered for the Convention. Delay no longer in taking advantage of the reduced rates accompanying these present days of early registration for the RI Convention in Atlanta next year.

WHEN WE LAST MET

Minutes from the June 22 Meeting



DR. SAM MATTHEWS

James Eubanks rang the opening bell for his last regular meeting as president by informing us it was National Fried Onion Ring Day. He analogized onion rings to the circle of Rotary-there is no beginning and no end. The good works of Rotary go on and on.

Sharon Mason delivered the invocation, and **Sam Matthews** introduced visitors and guests which included President James' family. President James also reminded us of the upcoming President's Dinner on June 30th. He also announced the following board decisions to donate funds:

- (1) \$2000 to MUST Ministries summer lunch program for children out of school;
- (2) 1500 to the Cobb Safety Village for a Rotary themed water safety display;
- (3) 750 to the Center for Family Resources in memory of Jennifer Cain's late husband, Cory; and
- (4) \$700 to the Police Athletic League summer gardening project.

This marks over \$26,000 in donations this year!

Past President **Dawn McEachern** introduced our speaker, Mark McLaughlin, M.D. Mark is a native of Dunwoody, obtained his undergraduate degree at Duke and his medical degree at the Medical College of Georgia. He then completed his residency at Shands Cancer Center in Jacksonville, Florida followed by additional training at the Mayo Clinic. He is a board certified radiation oncologist. After practicing in Phoenix, he relocated to the Atlanta area to take care of his parents.

Dr. McLaughlin is the director of the TomoTherapy® and CyberKnife® center of the Wellstar Cancer Network. The CyberKnife allows radiologists to focus an intense beam of radiation on the precise location of a tumor in order to kill it with much more precision than traditional surgery. This leads to fewer complications and a much quicker recovery time in most cases. Studies show the CyberKnife treatment is quite efficacious in appropriate cases. For example, many lung cancer patients are not good candidates for thoracic surgery due to already compromised lungs. The CyberKnife can treat some lung tumors without the need for invasive surgery.

Wellstar has an entire team which works with Dr. McLaughlin to handle these cases. The Wellstar team is the seventh largest in the United States and the second largest in the treatment of lung cancer. Patients from as far away as Great Britain have traveled to Marietta to undergo this treatment.

Meet Art Link

A New Member of Marietta Rotary

Art Link joined Abbott Hall and Joe Atkins for lunch recently at the Marietta Diner. After pondering the voluminous menu, they made their selections and enjoyed a pleasant meal. Art owns a successful real estate investing business purchasing, renovating, and reselling homes.

Originally from Philadelphia, Art attended Pershing College in Nebraska before moving to Atlanta to attend Georgia State University where he studied Trade Show & Hospitality Management. He has lived forty years in metro-Atlanta, including thirty years in Cobb County. Art spent many years in sales, operations, and management at some of America's retail giants... including The Home Depot, where he gained a strong background with home improvement issues. This specialty now serves him well with his real estate investments.

Starting with investing in himself, Art worked hard to learn real estate investment by observing and studying some of America's most successful investors. His office is filled with books and manuals on the topic. One of the first houses he considered was one which was particularly appealing to him because of its architectural design. He was tempted to purchase the house but after speaking with contacts he had made in the industry, he took their advice and passed on the opportunity. He learned a valuable lesson and avoided a \$50,000 loss – an investor cannot get emotionally attached to a property. Doing so will cloud his judgment. Later, when he located and purchased a much better property – his first – he restored it to its former glory and sold it with a net profit that almost equaled his annual salary from the retail business he left.

Art soon learned that it would be very important for him to cultivate a network of realtors, tradesmen, and potential investors in order to be successful. Perhaps one of the most important aspects of his business is the raising of capital needed to finance his purchases. As Art explained, it would be difficult for him to obtain bank loans without W-2 verifiable income. So he networks to locate private individuals who want to diversify their portfolio by passively investing in low risk mortgages with a consistently high rate of return. His weekly schedule of networking meetings fills an entire page. He even wrote a book on how people could benefit from the stability of short term investments like this.



In addition to operating his business, Art organized an essay contest for seventh and eighth grade students. Its purpose is to encourage student acceptance and respect for the racial, religious and cultural diversity among their friends, neighbors, and classmates, as more fully explained at the contest web site: www.EnlightenAmerica.org. Art also has a goal to purchase a hotel in Atlanta and gift it to the City of Atlanta, so the city can provide temporary housing for the homeless.

In his spare time, Art enjoys camping in the north Georgia and North Carolina mountains. He also occasionally visits his family in New Jersey.

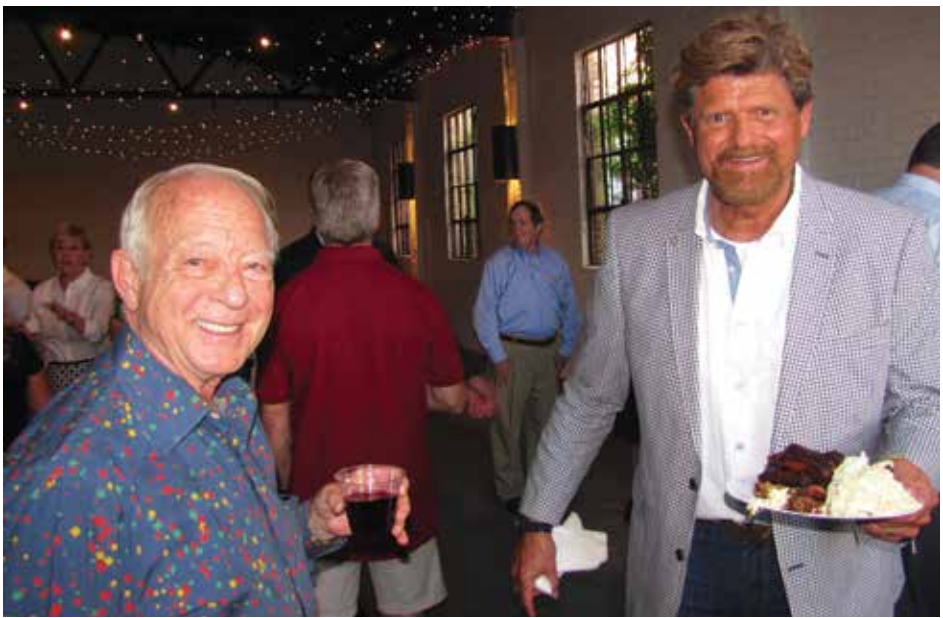
