


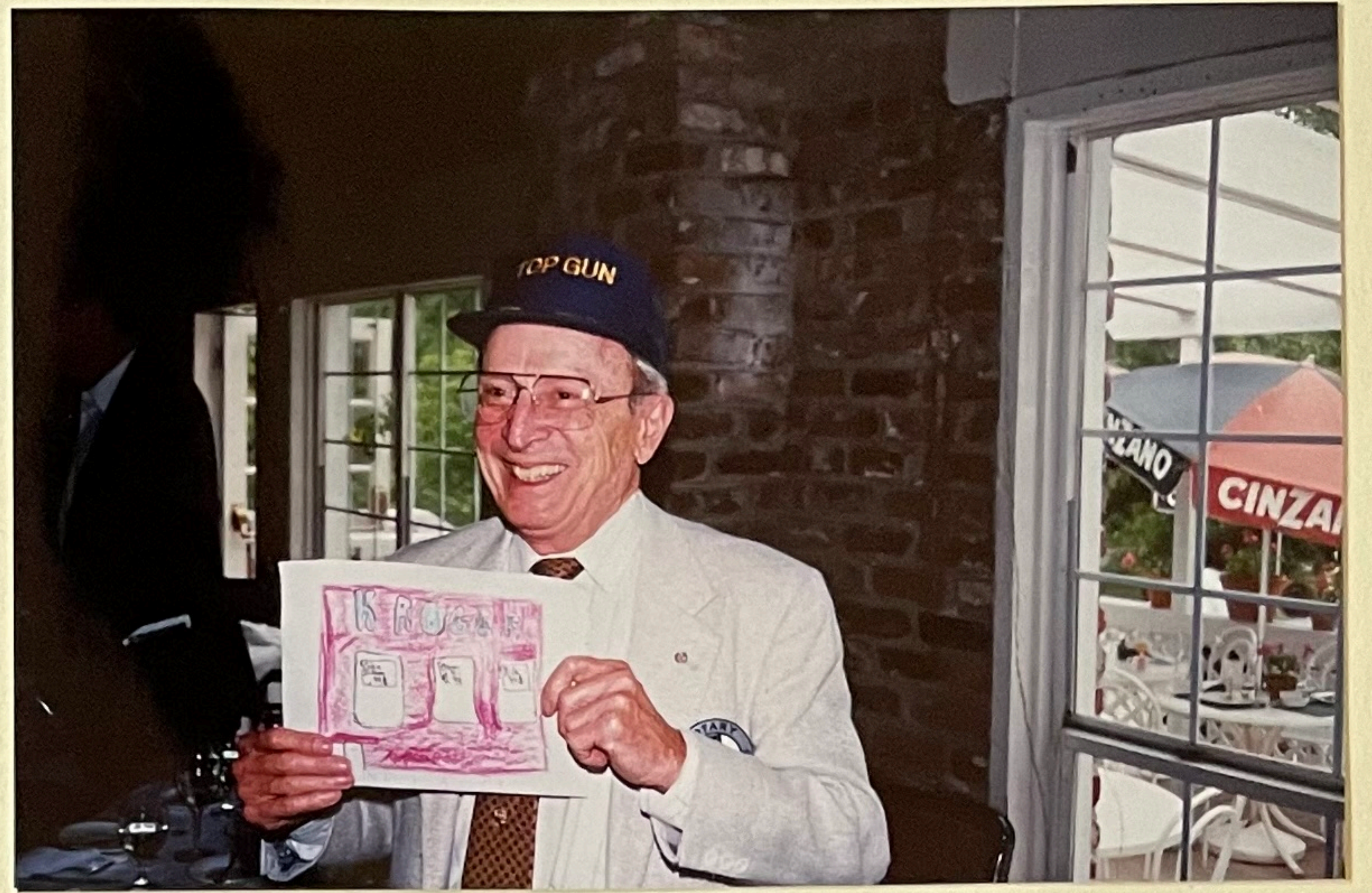

CALVARY CHILDREN'S HOME, INC.

The Calvary Children's Home of Smyrna, Inc. is a charitable, not-for-profit child care agency founded by Rev. Ben F. Turner, and accepted its first children in June, 1966. It was constructed and has been sustained in its operation entirely by free will gifts and donations from churches, civic groups, businesses and individuals. It has the endorsement of both state and local governments, the state and local Department of Family and Children Services, the Cobb County and Smyrna city government as well as local religious groups and churches of all denominations.

HISTORY

The first vision for a home such as Calvary took place on the streets of Jerusalem, Israel, several years ago when Rev. Ben F. Turner was conducting a tour group to Israel. A woman with five small children approached Rev. Turner and offered to sell him her baby for ten dollars. When told that he could not buy the child, she lowered the price to seven dollars, then dropped it to five saying she needed the money to support her other four children. Suffering from malnutrition, each child looked every bit like skeletons with skin stretched over them.

That experience continued to live with Rev. Turner until 1965, when the Calvary Children's Home moved from a touching experience in Israel to a reality.

A father and a mother, returning from the grocery store, were involved in an automobile accident in which both were killed. This left their six children without any family.

Since it is almost impossible to add six children to an already existing family, the children were separated and placed in four different homes. As they were being separated, Rev. Turner watched the children crying--the younger wanting to stay with the older. He realized the tremendous need for them to stay together, especially after losing both parents.... "If children can't have the love and guidance of parents, they should at least be able to live together as brothers and sisters. If I could build a home large enough, I could keep all the children of one family together." This was the incident that prompted the building of the Calvary Children's Home.

The children attend public schools and take part in community activities that will help them to become accepted and responsible citizens of society. We strive to help these children with a balanced approach to the physical, social, educational and spiritual needs of their life.

The children residing in the Home range in age from six to eighteen. Since we try to maintain a home atmosphere, the children may continue to live in the Home as long as they desire. Two of our young people will be attending college this fall, one young lady will attend West Palm Beach College, and a young man signed a football scholarship with West Georgia College. Presently, some of our young people have jobs and are working in the community. Many of our former residents are now married and have children of their own.

Since the Home's beginning in 1966, we've had the privilege of offering a home to over 400 children. Our desire is to provide them with opportunities which challenge and prepare them for life in an adult society by showing love, acceptance, understanding and encouragement.

CURRENT FACILITIES AND STAFFING

The original structure of the Calvary Children's Home consisted of one building with two rooms for the girls on one end, and two large rooms for the boys on the other. These facilities were designed to accommodate between 10 and 15 children, with a kitchen and dining area, and supervision provided by houseparents. Once accepting children, we received many calls from the Juvenile court, individuals and local pastors in the community seeking placement for children in need.

Since our facilities are located within a small residential neighborhood, our capacity for growth is totally restricted. Our property joined Dobbins Air Force Base on the north side, and while we could not place any structures on the base, they did allow us to use the large field for a garden, playground and activities area. Because we were granted access to that property, we had adequate space for our children's activities. However, in 1986, the Department of Transportation began construction on a limited access highway across the Dobbins property. As a result, we lost our garden, our playground area and our softball field. Since none of our property was taken during the acquisition process, the Children's Home received no compensation from the state or county. As a result of our losing this area, the total land area to house 25 to 30 children, plus staff, consists of less than acre.

Through the years, the care required by our children, due to more severe family situations, require a smaller staff-to-child ratio; thereby, requiring our adding additional staff. We presently have a staff residing with the children, consisting of houseparents for the girls, houseparents for the boys and one young man to do relief work with our boys.

In June of 1986, our home celebrated 20 years of providing care for children. We were able to contact approximately 100 of the former residents of our Home and invite them to a reunion. Approximately 70 to 75 returned to renew old friendships and to

show off their own families. It was quite a special time listening to the old "war stories" and watching as they interacted with those with whom they had once lived. It was most rewarding to hear of the careers and choices that they had made in their lives, with the one common thread that was evident through every one--a deep commitment to keeping their family together.

FUNDING

The Calvary Children's Home is a not-for-profit 501(c)(3) corporation. Our work is funded entirely by private donations, gifts and free will offerings from various church groups, civic organizations, businesses and individuals but receives no state, local or federal funding.

The Home is operated independently of any particular church and is governed by a Board of Directors of conscientious men and women from all walks of life.

Contributions donated to the Calvary Children's Home are used solely for the upkeep and operation of the Home and for the needs of the children.

PROJECTIONS AND GOALS

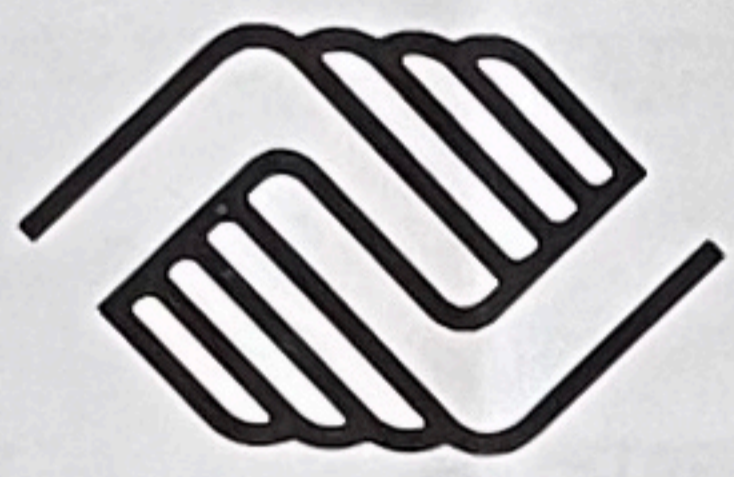
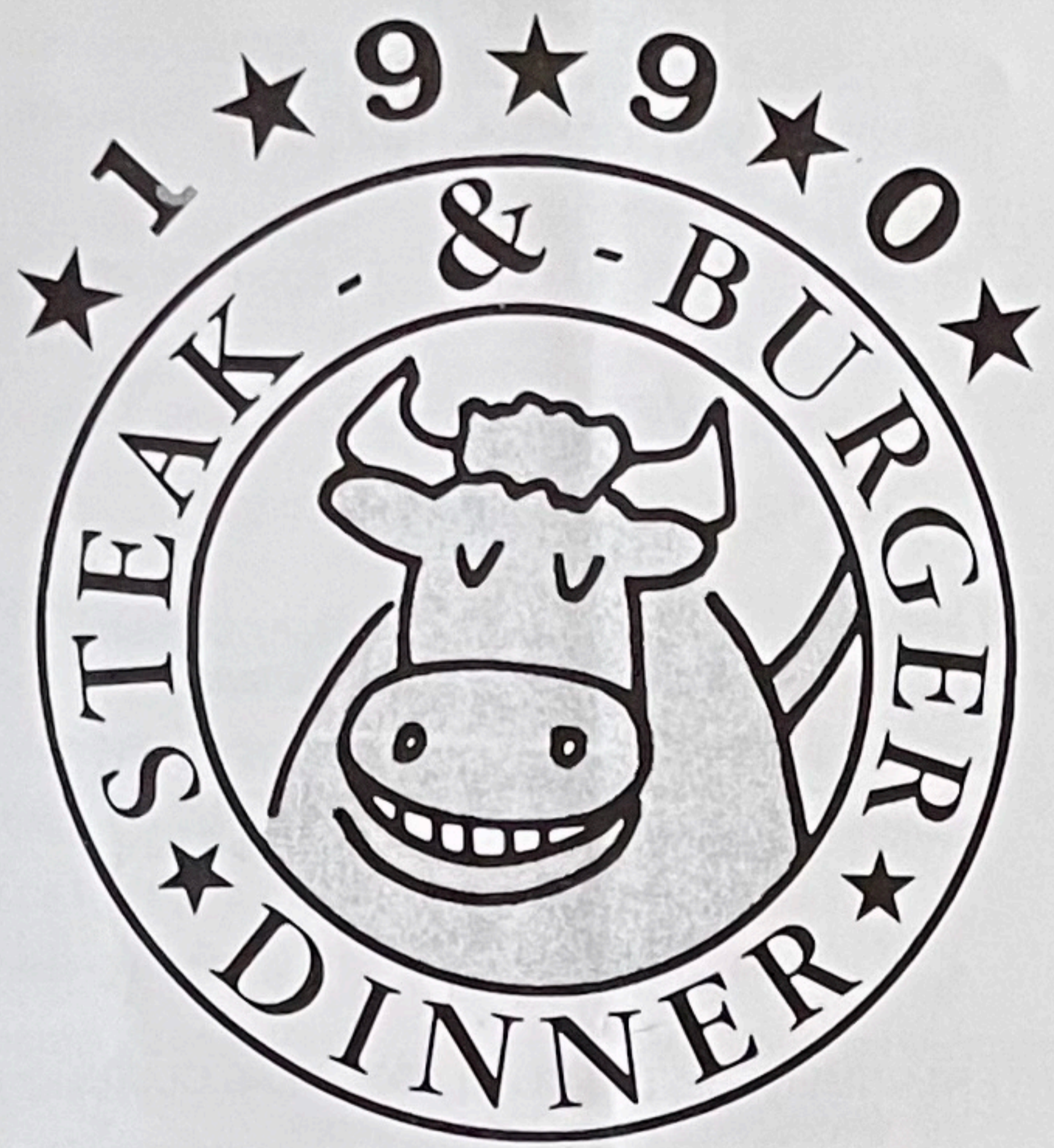
As a result of the new road being built and the desperate need for land for recreation and expansion, we have begun a concentrated drive to relocate our Home. We have established a building fund to enable us to proceed with this effort. We anticipate the expense for such an undertaking to be approximately one and one-half million dollars, depending on the cost and location of the land.

The future of the Calvary Children's Home will be, as it always has, in the hands of our friends. We are committed to providing the best possible home to these children but we cannot do the work alone. Your interest is important because of the encouragement it gives. It helps our children believe they are important when they see people that they do not even know taking such an interest in them.
